# VIRGINIA BEACH NEPTUNE FESTIVAL PRINCE/PRINCESS APPLICATION

Being a Neptune Festival Prince or Princess is an honor and a truly fantastic experience - it must not be taken lightly. During the year, it will be your opportunity and role to serve as an ambassador for the City of Virginia Beach as well as for the Virginia Beach Neptune Festival.

If you are chosen to serve in this position, you must be prepared to commit to our expectations of your time and attention. As a member of the 52<sup>nd</sup> Royal Court of Neptune, you will find an opportunity to learn, to have new experiences, to meet the leaders of Virginia Beach and Hampton Roads, and to broaden your horizons. It will be up to you to make the most of this opportunity through your attitude, commitment, and enthusiasm.

Please make certain that you are ready to accept this responsibility as you make your decision to apply.



## **GENERAL INFORMATION**

The <u>52<sup>nd</sup> Annual Virginia Beach Neptune Festival</u> will provide an opportunity for residents of Virginia Beach and visitors to our city to mix and mingle in an atmosphere of festive fun, to develop a sense of community pride, and to enjoy and celebrate together the special heritage that characterizes the City of Virginia Beach. Royal Court members serve as the visible embodiment of community service and are recognized as role models across our city.

Most Neptune Festival events take place during the month of September; however, there are many Royal Court activities that occur throughout the year.

Representatives from local high schools will be designated as "Princes and Princesses of the Royal Court." Along with Tritons and their partners, they will accompany King/Queen Neptune to official functions during the 2026 season.

All students who are presently juniors and will be entering their senior year in Fall 2026 at an accredited local high school are invited to apply for selection.

#### **ELIGIBILITY REQUIREMENTS:**

- 1. Enrollment in an accredited local high school for at least one (1) year prior to application
- 2. Scholastic grade point average of 2.75 or above
- 3. Continued residency in the City of Virginia Beach and enrollment in the Senior Class of an accredited local high school for the 2026-2027 scholastic year
- 4. Demonstrated active participation in school, community, and/or civic organizations

Selection will be based on an applicant's poise, communication skills, and personality.

APPLICANTS SHOULD POSSESS SOME KNOWLEDGE OF THE NEPTUNE FESTIVAL AND ITS ROLE IN OUR COMMUNITY

#### 1. INCOMPLETE APPLICATIONS WILL BE DISQUALIFIED

- 2. Absence from the Preliminary Interviews and/or Final Interviews (if selected as a finalist) will result in disqualification. **NO EXCEPTIONS**
- 3. <u>Finalists must be accompanied by a parent</u> on Tuesday, November 25th at 7:00pm for a final meeting with festival leadership.
- 4. Applicants should plan to reserve the entire evening on both dates for the selection process. Depending on the number of applicants, the selection process may go until 10:00pm on both nights. Every effort will be made to finish as expeditiously as possible.
- 5. Festival officials reserve the right to disqualify any applicant who is deemed not to have met the requirements of the criteria as stated, or whose actions are not consistent with the spirit of the festival. *Once selected, a member of the Royal Court is subject to removal at any time for infractions of the rules or for lack of cooperation with festival leadership.*

## PRINCE/PRINCESS RESPONSIBILITIES

Neptune Festival Princes and Princesses are expected to be available for ALL scheduled events, including rehearsals. This schedule is subject to <u>additions and revisions</u>, among them will be wardrobe fittings and events which cannot yet be scheduled.

THERE WILL BE A MANDATORY MEETING IN JANUARY 2026 AT THE NEPTUNE FESTIVAL OFFICE FOR ALL PRINCES AND PRINCESSES. WE WILL SELECT A DATE WHEN ALL ARE AVAILABLE.

#### **GENERAL REQUIREMENTS:**

- 1. The commitment one makes as a member of the Neptune Festival Royal Court is a serious one. In addition to the fun and excitement of festival events, there is preparation, rehearsal time, and energy involved. Before accepting this responsibility, one should have a full understanding of what is expected. All questions should be directed to Mrs. Krista Booth at the Neptune Festival office at (757) 498-0215 prior to making a decision to enter the selection process.
- 2. It is important that all Royal Court members attend all meetings, rehearsals, and fittings as requested. Festival officials will not be able to accommodate each person's individual commitments; therefore, each person is expected to arrange their schedule to prioritize these responsibilities. Promptness and preparedness are expected.
- 3. At all times, members of the Court should display conduct befitting their status as a representative of the festival, their community, and themselves.
- 4. The Parent Consent form should be read jointly with parent(s) before signing.

## PARENT AND APPLICANT PROCEDURE AND POLICY

Young gentlemen and ladies who are selected as Princes and Princesses for the Neptune Festival Royal Court are consistently among those whose activity schedules are full. They are members of sports teams, school committees, clubs, and community groups. Their very involvement in such is a part of what prepares them for the role of Neptune Festival Prince or Princess. Festival officials recognize that these commitments are important and a valuable part of each young adult's life. However, these young people and their parents who accept an invitation to join the Royal Court must understand the promise they are making. The festival cannot meet its obligations and fulfill its duties without such an understanding.

Therefore, we wish to make clear our expectations. Princes and Princesses are required to attend ALL functions whether scheduled at this time or added later. Unfortunately, all activities cannot be set this far ahead; however, the dates for the Neptune Coronation Gala and Boardwalk Weekend have been set and are <u>NOT ADJUSTABLE</u>. The Neptune Coronation Gala is scheduled for March 21, 2026, and all Princes and Princesses must be available for a 9:00am rehearsal and for the Gala itself later that afternoon and evening. The Boardwalk Weekend dates are scheduled for September 25, 2026 – September 27, 2026, and Princes and Princesses must stay with us at the Hilton Virginia Beach Oceanfront Hotel for the entire weekend. Unless excused by a Festival official, absence from an event constitutes a violation of one's contract.

We ask that you please consider this policy <u>carefully</u> when making the decision to enter the selection process and/or accepting an invitation to the Royal Court.

#### **EXPENSES**

Prince/Princess expenses are significant and are primarily borne by the festival. They include meals, refreshments, transportation, wardrobe, and hotel accommodations (for Boardwalk Weekend). There will be some expenses which must be borne by the participant.

A fee of \$100 is assessed to each Prince and Princess to cover some costs. This fee is due and payable upon acceptance into the Royal Court. Alterations to Royal Court clothing, if necessary, are the responsibility of the participant.

Parents/guardians of the Princes and Princesses are responsible for their own expenses at Neptune Festival events.

Please be acquainted with the requirements noted in the "Prince / Princess Responsibilities" prior to signing the Parental Consent Form.

I/We further release the City of Virginia Beach, the Neptune Festival, their respective volunteers, members, agents, and employees, and waive any claim against them, jointly or severally, and hereby agree to defend, indemnify, save, and hold them harmless from and against any and all claims of any nature including, but not limited to, bodily injury or death to our child or others, damage of property, attorney's fees and costs, and otherwise occasioned by their participation in any Neptune Festival activity, which is organized, sponsored, supervised, and/or controlled by the Virginia Beach Neptune Festival and its parent corporation, Virginia Beach Events Unlimited, Inc.

Their participation is completely voluntary, and they assume all risks and hazards incidental to the activities or events in which they participate.
